- We believe that this basket of 10 wines will **outperform the boarder fine wine market** over the medium to long-term. This is because *Wine Advocate* (Robert Parker) 100-point wines retain a prestige which gives them a **global appeal** on which all collectors and investors can agree. It is like a bond having a AAA rating from S&P.
- The *average* price for a 100-point (75cl bottle) Bordeaux wine is £914. This underlines how relatively undervalued wines like **Pontet-Canet 2010** still are at £115 per bottle.
- We were surprised that 7 of the cheapest 100-point wines were from **Bordeaux**. This shows that there is still **excellent value** to be found in France's premier investment region, as long as you are prepared to trust *Wine Advocate* and venture outside the First Growth / Right Bank top pricing tier.
- All the wines on this list have at least two decades of improvement in the bottle to go, ensuring that they have ample time to appreciate in value.
